- (c) To insure houses, tenements, merchandise and all other property and effects, real and personal, against loss or damage by fire, storm, earthquake, shock, fire resulting, from earthquake, accident or otherwise, to carry on the ordinary business of fire insurance in all the aforesaid branches
- (d) To insure against every description of marine risk, which may legally be undertaken, relating to the perils of the sea, fire, war, reprisals and all other risks of a like nature incidental to the seas, ships, vessels, and water craft of a descriptions, and also the freights, goods, merchandise, cargo and all property whatsoever in or on board the same, so far as the same may be effected or made according to law, and to insure all other matters and things which lawfully may or can be from time to time insured or be the subject of insurance against perils of the sea.
- (e) To guarantee and to indemnify merchants, traders and those engaged in business and giving credit, from loss or damage by reason of giving and extending such credits to their customers or persons dealing with them and to guarantee the performance, promises or duties, of all kinds other than insurance policies.
- (f) To engage in the business of personal accident, motor car, miscellaneous insurance other than life insurance and to indemnify against loss by burglary, theft, forgery, embezzlement or by one or more of such happenings.
- (g) To act as agent for insurance companies of every class and to conduct a general insurance agency or insurance brokerage business.
- (h) To lend money or grant loans or other credit facilities secured by real estate mortgage or other collateral security, subject to the requirements of law and pertinent regulations.
- (i) And in general, to engage in the business of insurance and guaranty in any branches except in life insurance business, or a consideration, to indemnify any person, firm or corporation against loss, damage or liability arising from an unknown or contingent event, and to guarantee liabilities and obligations of any persons, firm or corporation, and to act as agent of other insurance or surety companies in any branch or insurance, with the exception of insurance. 10:56:32 AM

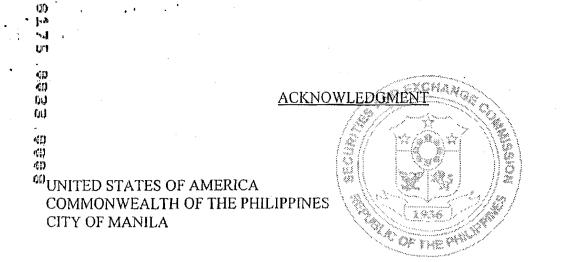
